#### **Applicant Privacy Notice**

# THIS POLICY APPLIES TO ALL INNOSPEC INC GROUP COMPANIES, OFFICES AND EMPLOYEES OPERATING IN THE EUROPEAN ECONOMIC AREA (EEA)

#### 1. What is this document and why should you read it?

- 1.1 This privacy notice explains how and why Innospec Inc including each of its operating entities in the EEA (also referred to as "Innospec", "we", "our" and "us") uses personal data about individuals who apply to work with us either as employees, staff, contractors, trainees or consultants (referred to as "you").
- 1.2 You should read this notice, so that you know what we are doing with your personal data. Please also read any other privacy notices that we give you, that might apply to our use of your personal data in specific circumstances in the future. There is a separate Employee Privacy Notice that will apply to you if you are offered employment or engagement by Innospec.
- 1.3 This notice does not form part of any contract of employment or any other contract to provide services.

#### 2. Innospec's data protection responsibilities

- 2.1 "**Personal data**" is any information that relates to an identifiable natural person. Your name, address, contact details and CV are all examples of your personal data, if they identify you.
- 2.2 The term "**process**" means any activity relating to personal data, including, by way of example, collection, storage, use, consultation and transmission.
- 2.3 Innospec is a "**controller**" of your personal data. This is a legal term it means that we make decisions about how and why we process your personal data and, because of this, we are responsible for making sure it is used in accordance with data protection laws.

#### 3. What types of personal data do we collect and where do we get it from?

- 3.1 We collect different types of personal data about you for various reasons. We cannot administer your application for employment or engagement without your personal data. Where we don't need your personal data, we will make this clear, for instance we will explain if any data fields in our application processes are optional and can be left blank.
- 3.2 Further details of the personal data we collect, where we get it from and what we do with it are set out in **Schedule 1**.
- 3.3 You provide us with personal data directly when you apply for a job with us. We also create some personal data ourselves and obtain some personal data from other sources. We obtain it from other people and organisations, including recruitment agents, some public sources, such as publically available directories and online resources, your emergency contacts and former employers. You can read more about the sources of personal data in the more detailed information set out in as explained in **Schedule**1.
- 3.4 If any of the personal information you have given to us changes, such as your contact details, please inform us without delay by contacting the HR department or your recruitment contact.

#### 4. What do we do with your personal data, and why?

- 4.1 We process your personal data for particular purposes in connection with your application for employment or engagement with us, and the management and administration of our business.
- 4.2 We are required by law to always have a permitted reason or justification (called a "lawful basis") for processing your personal data. There are **six** such permitted lawful basis for processing personal data.

The table at **Schedule 2** sets out the different purposes for which we process your personal data and the relevant lawful basis on which we rely for that processing.

- 4.3 Please note that where we have indicated in the table at **Schedule 2** that our processing of your personal data is either:
  - 4.3.1 necessary for us to comply with a legal obligation; or
  - 4.3.2 necessary for us to take steps, at your request, to potentially enter into an employment contract with you, or to perform it

and you choose not to provide the relevant personal data to us, we may not be able to enter into a contract of employment or engagement with you.

4.4 We may also convert your personal data into statistical or aggregated form to better protect your privacy, or so that you are not identified or identifiable from it. Anonymised data cannot be linked back to you. We may use it to conduct research and analysis, including to produce statistical research and reports. For example, to help us understand how many of our applicants have certain protected characteristics for equal opportunities monitoring.

#### 5. Special category personal data (including criminal data)

We are required by law to treat certain categories of personal data with even more care than usual. These are called sensitive or special categories of personal data and different lawful bases apply to them. The table at **Schedule 3** sets out the different purposes for which we process your special category personal data and the relevant lawful basis on which we rely for that processing. For some processing activities, we consider that more than one lawful basis may be relevant – depending on the circumstances.

#### 6. Who do we share your personal data with, and why?

6.1 Sometimes we need to disclose your personal data to other people.

Inside the Innospec group

- We are part of the Innospec group of companies. Therefore, we will need to share your personal data with other companies in the Innospec group for our general business and workforce management purposes, for line management purposes, incident and accident reporting, authorisations/approvals with relevant decision makers, parental reporting and where systems and services are provided on a shared basis.
- 6.3 Access rights between members of the Innospec group are limited and granted only on a need to know basis, depending on job functions and roles.
- Where any Innospec group companies process your personal data on our behalf (as our processor), we will make sure that they have appropriate security standards in place to make sure your personal data is protected and we will enter into a written contract imposing appropriate security standards on them.

Outside the Innospec group

- 6.5 From time to time we ask third parties to carry out certain business functions for us, such as recruitment agencies, cloud data storage and IT support. These third parties will process your personal data on our behalf (as our processor or joint controller). We may disclose your personal data to these parties so that they can perform those functions. Before we disclose your personal data to other people, we will make sure that they have appropriate security standards in place to make sure your personal data is protected and we will enter into a written contract imposing appropriate security standards on them.
- 6.6 We have set out below a list of the categories of recipients with whom we are likely to share your personal data:

6.6.1 consultants and professional advisors including legal advisors and accountants;

- 6.6.2 medical screening and occupational health provision;
- 6.6.3 background check providers;
- 6.6.4 business partners and joint ventures;
- 6.6.5 trade associations and professional bodies;
- 6.6.6 governmental departments, statutory and regulatory.

We may also share your personal data with third parties, as directed by you.

#### 7. Where in the world is your personal data transferred to?

- 7.1 If any of our processing activities require your personal data to be transferred outside the European Economic Area, we will only make that transfer if:
  - 7.1.1 the country to which the personal data is to be transferred ensures an adequate level of protection for personal data;
  - 7.1.2 we have put in place appropriate safeguards to protect your personal data, such as an appropriate contract with the recipient;
  - 7.1.3 the transfer is necessary for one of the reasons specified in data protection legislation, such as the performance of a contract between us and you; or
  - 7.1.4 you explicitly consent to the transfer.

#### 8. How do we keep your personal data secure?

We will take specific steps (as required by applicable data protection laws) to protect your personal data from unlawful or unauthorised processing and accidental loss, destruction or damage. For more information, please request a copy of our Group IT Security Policy from the HR department or your recruitment contact.

# 9. How long do we keep your personal data for?

- 9.1 We will keep your personal data for as long as is necessary in connection with both our and your legal rights and obligations. This may mean that we keep some types of personal data for longer than others.
- 9.2 We will only retain your personal data for a limited period of time. This will depend on a number of factors, including:
  - 9.2.1 any laws or regulations that we are required to follow;
  - 9.2.2 whether we are in a legal or other type of dispute with each other or any third party;
  - 9.2.3 the type of information that we hold about you; and
  - 9.2.4 whether we are asked by you or a regulatory authority to keep your personal data for a valid reason.
- 9.3 Specific retention periods for certain documents are set out below:

Application Forms /	If your application is unsuccessful, these documents will usually be retained					
CVs	for one year after the successful candidate commences employment.					
	However, if the successful candidate requires specific visa or other sponsorship then the retention period (in respect of both application forms, CVs and other documents) will be longer in relation to those candidates shortlisted for interview and will need to be in line with our sponsor obligations.

	If your application is successful, these documents will be retained for 7 years following the end of your employment.
References received	References received from former employers will be retained for one year after the successful candidate commences employment and for 7 years following the end of your employment if you are the successful candidate.
Criminal Record Checks	For roles requiring a standard or enhanced criminal record check, the results will be retained for the duration of employment and any subsequent period required by the relevant authority / regulations under which the check has been conducted.
	For roles requiring a basic criminal record check, this data will be retained until the successful candidate commences employment (unless we have a contractual obligation with a customer or other third party to retain this for longer). A note will be maintained on file for the duration of employment that the check results were satisfactory.
	If the successful candidate requires specific visa or other sponsorship and a criminal record check is a requirement of the role then the criminal record check will be maintained in accordance with the sponsor obligations referred to above.

9.4 If you are successful in your application, the retention provisions set out in our Employee Privacy Notice will apply to your personal data.

#### 10. What are your rights in relation to your personal data and how can you exercise them?

- 10.1 You have certain legal rights, which are briefly summarised at **Schedule 4**, in relation to any personal data about you which we hold.
- 10.2 Where our processing of your personal data is based on your **consent**, you have the right to withdraw your consent at any time. If you do decide to withdraw your consent we will stop processing your personal data for that purpose, unless there is another lawful basis we can rely on in which case, we will let you know. Your withdrawal of your consent won't impact any of our processing up to that point.
- 10.3 Where our processing of your personal data is necessary for our **legitimate interests**, you can object to this processing at any time. If you do this, we will need to show either a compelling reason why our processing should continue, which overrides your interests, rights and freedoms or that the processing is necessary for us to establish, exercise or defend a legal claim.
- 10.4 If you wish to exercise any of your rights please contact the HR department or your recruitment contact in the first instance.
- 10.5 You also have the right to lodge a complaint with the relevant data protection supervisory authority for the country location of the role that you have applied for.

#### 11. Updates to this notice

We may update this notice from time to time to reflect changes to the type of personal data that we process and/or the way in which it is processed. We will update you on material changes to this notice by updating the version of this notice held on our website. We encourage you to check this notice on a regular basis.

# Your rights in relation to personal data

Your right	What does it mean?	Limitations and conditions of your right
Right of access	Subject to certain conditions, you are entitled to have access to your personal data (this is more commonly known as submitting a "data subject access request").	If possible, you should specify the type of information you would like to see to ensure that our disclosure is meeting your expectations. We must be able to verify your identity. Your request may not impact the rights and freedoms of other people, eg privacy and confidentiality rights of other staff.
portability  personal data which you have provided to us and which is processed by us by automated means, in a structured, commonly-used machine readable format.		If you exercise this right, you should specify the type of information you would like to receive (and where we should send it) where possible to ensure that our disclosure is meeting your expectations. This right only applies if the processing is based on your consent or on our contract with you and when the processing is carried out by automated means (ie not for paper records). It covers only the personal data that has been provided to us by you.
Rights in relation to inaccurate personal or incomplete data	You may challenge the accuracy or completeness of your personal data and have it corrected or completed, as applicable. You have a responsibility to help us to keep your personal information accurate and up to date.  We encourage you to notify us of any changes regarding your personal data as soon as they occur, including changes to your contact details, telephone number, immigration status.	Please always check first whether there are any available self-help tools to correct the personal data we process about you. This right only applies to your own personal data. When exercising this right, please be as specific as possible.
Right to object to or restrict our data processing	Subject to certain conditions, you have the right to object to or ask us to restrict the processing of your personal data.	As stated above, this right applies where our processing of your personal data is necessary for our legitimate interests. You can also object to our processing of your personal data for direct marketing purposes.
Subject to certain conditions, you are entitled to have your personal data erased (also known as the "right to be forgotten"), eg where your personal data is no longer needed for the purposes it was collected for, or where the relevant processing is unlawful.		We may not be in a position to erase your personal data, if for example, we need it to (i) comply with a legal obligation, or (ii) exercise or defend legal claims.
